work. He has spent many tireless hours advocating for our patients and our profession. I would like to also recognize Dr Brent Holman, our executive director. He is very passionate about dentistry and a great advocate for our profession. He is very knowledgeable and a great asset to the association. A great thank you also goes out to the Board members, Speaker of the House, and the Assistant Executive Director.

We had a great annual session this year. It was a great opportunity to connect with old friends and make new ones. It is refreshing and encouraging to see so many young dentists attending scientific and social functions. Special thanks go out to our out-of-state guests who took time away from their busy offices and families to join us. We had a great exhibitor turn-out and our exhibit hall was sold-out. This helps generate non-dues revenue. Please remember to thank the exhibitors and support them the way they support your meeting.

At the annual session, your House of Delegates considered and passed several resolutions which I would like to summarize. First, given the Central Office and Board of Trustees' ability to evaluate future speakers, the Council on Scientific Programs was dissolved. Second, in order to encourage outreach programs and help reduce barriers to dental care in North Dakota, a resolution was passed in support of a dental hygienist Collaborative Practice Agreement that links high-risk patients to dental homes. Third, the association expenses are increasing. We are facing legislative challenges for which we have recruited the assistance of a lobbyist. Furthermore, it has become more expensive to

run the annual meeting and central office. Your NDDA dues will therefore go up by \$150 effective the year 2016. This is the first true dues increase since 2008. Fourth, I am sure you are familiar with the list of "Top 10 Solutions" developed by your association to help reduce barriers to dental care. Those solutions are evidence-based key components to help care for the underserved in North Dakota and the HOD passed a resolution to support them. Fifth, a resolution to support the Mission of Mercy. The North Dakota Dental Association will partner with the Minnesota Dental Association in sponsoring a ND/MN Mission of Mercy event in the Fargo-Moorhead area on July 22-23, 2016, with the goal of providing an estimated 1 million dollars of donated dental care to 2,000 patients. More details will be forthcoming. I hope you and your staff will volunteer time and talent to support this noble cause.

The push continues from outside parties to introduce a new workforce model as the answer to barriers to dental care. We feel that the solution is multi-faceted. We continue to lead the conversation with our "Top 10 Solutions". You may have heard about CODA's (Commission on Dental Accreditation) authorization to establish an accreditation process for dental therapy education programs. The commission voted to implement those standards not as an

endorsement but to clarify inconsistencies. Our message continues to be the same: we want evidence-based, North Dakota tailored, solutions that make a meaningful difference now and not cookie-cutter experiments.

We have reported in the past that, while our Medicaid utilization has improved, we continue to lag behind other states. We have asked you to make a pledge to take more Medicaid patients through our "Take 5 More" Initiative. I am pleased to report that many of you have answered the call. I challenge the rest of you to do the same. We have also convened a Medicaid Advisory Committee that is made up of dentists from across the state. That group will meet quarterly with the Department of Human Services to establish a dialogue with the Department of Human Services to improve administration.

I look forward to a fantastic year and hope to see you at the Midwinter meeting in January in Bismarck.

in the state, our membership remains vibrant. Our annual session in Fargo was well attended and it is exciting that our biggest age demographic is now the "under 35" group! Please engage with your association, your community, and your legislator; you can make a difference!

As you have probably noticed, there has been an increase in the number of survey requests from the NDDA Central Office for a variety of issues. There was recently a survey sent that asks if you have any interest in volunteering or contracting with a variety of non-profit opportunities in the state. These opportunities include community non-profit clinics, Indian Health Service clinics, and missions. There are many dentists who have provided services in these venues for many years; it's our goal to not only document these efforts but make it easier to engage in these activities going forward. Please respond to the survey; the opportunity to give of your professional talents is a gift....take it!

As you probably know, you will see a dues increase when you get your dues statement in December. The NDDA has maximized nondues revenue and cut costs in the last several years but the time has come to look at our dues structure to maintain our effectiveness. The House of Delegates approved this increase so that we can maintain our ability to adequately represent our patients and our profession, respond to rapidly-increasing meeting costs, and to offer the service that you expect. As you also may know, 95% of our members want us to oppose any attempts legislatively to allow non-dentists to provide irreversible dental services. This issue is still in play despite a resounding defeat in the last legislative session. The Legislature's interim Health Services Committee is still considering this issue at its quarterly meetings. The NDDA will continue to make its opposition a priority. That means you need to make it a priority as well by acting. Call you legislator now, introduce yourself, and take them to lunch or coffee to express your concerns. It makes a difference!

ADA 10th District News

This fall I had the opportunity to represent the American Dental Association at the FDI Annual World Dental Congress hosted by the FDI World Dental Federation and the Dental Association of Thailand in Bangkok, Thailand.

Bangkok became the capital of Thailand in 1782. Thai people rarely call their capital "Bangkok" but instead refer to it as "Krung Thep" (City of Angels). My first impressions were: several hundred skyscrapers as far as the eye could see, being stuck in heavy traffic congestion, intense heat and humidity, and a "city of smiles that never sleeps". After getting comfortable with the renowned "Sky-train" system-traveling above the stand still traffic, we were able to explore magnificent temples and palaces, a busy river and canal system, and markets and shops wanting to sell you anything from cheap souvenirs to hand made silk suits. Thai people are warm, friendly and generous. I am blessed to have experienced a country so different and special.

Thailand is among a group of Asian countries likely to provide significant growth opportunities in the dental market due to the rising population and increasing per capita income of its large middle class population. Rising awareness levels about oral health have created a demand for dental services. A universal coverage program, implemented in 2002, gives Thai citizens better access to health services, including dental services.

This was the first time that Thailand hosted the annual meeting of the FDI. The meeting was a huge success attracting 12,000 dentists from Thailand and several hundred dentists from all over the world. The theme of this year's Congress was "Dentistry in the 21st Century."

The FDI World Dental Federation Annual World Congress comprises several elements.

- 1. Scientific programs speakers from around the world focused on the latest scientific topics affecting our profession globally.
- 2. A World Dental Exhibition showcasing the latest state-of —the art advanced dental technology, equipment and products. Where else but an international dental exhibition can you find and try out the newest technology available from all over the world? I really enjoyed watching the Thai dental students walking through the exhibit floor with their eyes wide open and jaws dropped.
- 3. The World Dental Parliament this was the main reason we attended this international meeting. The Parliament was a five day gathering of over 300 dentists representing 130 countries to establish strategic direction and adopt policy statements that affect the world of dentistry with it vision of "Leading the world to optimal oral health."

The World Dental Parliament was productive. We made a number of important decisions – the number one was electing the ADA's very own Dr. Kathy Kell for FDI President Elect. Kathy has served the FDI for 17 years in many roles: as their treasurer, past counselor, committee member, task teams member and now their future President. This is the first time in three decades that an ADA member will serve as president-elect to the FDI. In addition, the FDI Council appointed Dr. Tomas Hart to the FDI Science Committee. Dr. Hart is the director of the ADA Foundation Volpe Research Center. The FDI Council also appointed ADA member Dr. Marshall Gallant to serve on the FDI Public Health Committee. Dr. Gallant is chief of dental services at the Orlando Veterans Administration Medical Center, one of the largest government-funded oral health care institutions in the U.S.

What else did we accomplish? As a delegation representing the ADA we had many issues to discuss. Through international collaboration with other national dental societies we were able to strengthen our profession and protect and serve the public. Some of the key issues discussed:

- Confirmation of the FDI Strategic Plan which focuses on membership, communication, leadership and strengthening relationships with WHO, UN, UNEP, UNICEF and other global agencies.
- Adopted the 2016 Budget with the help and direction of ADA President Maxine Feinberg serving on the Budget Reference Committee.
- Adopted nine new policy statements. Policy Statements are declarations laying out current FDI thinking on various issues related to oral health, oral health policies and the dental profession. Many FDI Policy Statements are the result of projects carried out by the FDI Science Committee and Dental Practice Committee. Others are developed in collaboration with entities such as the American Dental Association working with the World Health Organization and the International Dental Research Institute. The ADA needs to be at the table to provide our science, standards, education and evidence based dentistry facts.

- FDI Unilever partnership continues in 2016 under the banner of "Brush Day and Night."
- Introduction of the second edition of the FDI's Oral Health Atlas "The Challenge of Oral Disease A Call for Global Action." This is a book highlighting the extent of the worldwide problem of oral disease. The atlas aims to serve as an advocacy resource for all oral health care professionals and recommends strategies to address the global challenge of oral disease.
- Received reports from the five standing committees responsible for addressing issues of communication, member support, dental practice, education, science, world dental development and health promotion.
- Much discussion within our delegation of what we can accomplish over the next few years at FDI- possible political issues coming in the future for global oral health.
- Celebration and reflections of a successful World Oral Health Day on March 20, 2015 and plans for continued observance of WOHD 2016 Smiles for Life Campaign.

Apart from the formal FDI Congress Assemblies, several break-out classes and forums were offered with information and discussions concerning oral health prevention and education, the environment and public health issues. We had special assignments from Dr. Gregory Chadwick, the USA Chair, to attend, participate and report back to our delegation information from these forums. This year I attended my third world oral health forum. These forums offer a platform for the discussion of hot topics in the field of public oral health. This year's forum concentrated on the recently published World Health Organization's (WHO) guideline on the sugar intake for adults and children, which recommends a reduction in daily intake of free sugars to less than five percent of total energy intake. Reducing free sugar intake to less than ten percent of total daily energy intake was recommended by the WHO for the first time in 1989. According to the expert presenters from the WHO, the further reduction of free sugar to less than five percent or roughly 25 grams (six teaspoons) per day would provide additional health benefits including the reduction of dental caries. As dentists we experience the effects of sugary drinks on our patients. A single can of sugar-sweetened soda contains up to 40 grams (ten teaspoons) of free sugars – nearly twice as much as WHO recommends in total per day. The negative consequence of sugar affects our patient's risk for dental caries and affects their general health with a link to obesity and diabetes.

As a delegation, the ADA was able to meet with other international delegates both formally and informally to discuss common problems and issues of emerging importance at luncheons and evening receptions. One interesting opportunity was a luncheon with the Japanese dental delegation. We were seated across from a Japanese delegate and shared common problems of oral health in our aging populations.

Another highlight was attending the opening session hosted by the Dental Association of Thailand. The keynote speaker was the Minister of Public Health. During the singing of the Thai Royal Anthem, we stood to pay homage to the King of Thailand. The King is very highly regarded, as evidenced by his picture displayed everywhere. A performance of traditional dance was a moving depiction of Thai history. The ceremony concluded with the naming of all 130 countries represented with each country standing and waving its flag upon being recognized.

After spending a week at the 2015 FDI meeting in Thailand, my third year as a delegate to the FDI Congress, I see a definite need to continue the ADA's involvement in the FDI World Dental Federation. The FDI works as a facilitator and convener for dental organizations and dentists world-wide. It represents the voice of over one million dentists worldwide. We need this vehicle to bring developed and developing countries, governmental organizations, educational institutions, experts in dental research and representatives from dental manufacturing and industry together for one common goal of promoting excellent oral health throughout the world. There is no other option. The ADA needs to be present to help the FDI to become a stronger organization. I thank you for this opportunity and experience to promote oral health throughout the world and represent the American Dental Association.

Medically fragile patients need dental care to qualify for lifesaving or lifesustaining treatments, such as chemotherapy, joint replacement, cardiac surgery and organ transplants.

Susan, age 58 and living in Dodge, was a former railroad management employee and a bus driver before she was forced to retire for medical reasons. In constant pain from fibromyalgia, Susan gets relief through regularly scheduled injections. She also has chronic obstructive pulmonary disorder and uses oxygen as needed.

Adding to Susan's problems, she was edentulous. With her income limited to a small railroad retirement disability payment, Susan's monthly expenses left nothing to

pay for the dentures she badly needed.

Dr. Alison Just, a general dentist and one of 135 volunteer dentists in Dental Lifeline Network's North Dakota DDS program, came to Susan's rescue. She fitted Susan with full upper and lower dentures fabricated by Bismarck Mandan Dental Lab, one of 12 dental labs in the state that volunteer for DDS. Several months later, Susan returned to Dr. Just to have her dentures relined.

"I can eat things that I couldn't eat before – salad, apples, steak and even peanuts. It's easier to digest my food. It made a great big difference. Dr. Just is wonderful, patient and understanding. I know people who can't talk without teeth. I wish more dentists would volunteer." – Susan



TOBACCO FREE NORTH DAKOTA SEEKS ASSISTANCE OF NDDA MEMBERS IN AAR IMPLEMENTATION

Tobacco Free North Dakota (TFND) recently presented information to and sought the assistance of the NDDA in statewide efforts to improve tobacco prevention and cessation in dental settings. Following a July 2014 to June 2015 report from the ND Department of Health, dentists were the source of less than 1% - just 0.75% - of referrals to the ND Quits program. Comparing that to the 38.41% of referrals that came from doctors, nurses, or other healthcare providers, NDDA leadership agreed that there was room for improvement within dental communities across North Dakota.

How can improvements be made? Through the adoption, implementation, and documentation of "AAR", a best practice, into your practice - ASK about tobacco use at every visit, ADVISE your patient to quit, and REFER your patient to ND

It's simple, efficient, and effective. It's simple thanks to EHRs/EMRs that incorporate tobacco use as a vital sign. AAR is efficient, taking only about 90-seconds, can be done by an assistant or hygienist, and rather than keeping additional paperwork in your office, an online referral form always

stays up-to-date and easy to print when needed (http:// www.nd.gov/eforms/Doc/ And sfn59499.pdf). implementation of AAR is effective.



LONG-TERM CARE INITIATIVE

The North Dakota Department of Health, Oral Health Program, with funding from the DentaQuest Foundation, will continue to expand oral health services into the long-term Care facilities. Currently, Bridging the Dental Gap is providing oral health services in six long-term care facilities in the Bismarck/Mandan area and Northland Community Health Center is providing oral health services in three long-term care facilities and expanding to another site. Funded partners through this initiative include Northland Community Health Center-Rolette, Center for Rural Health at the University of North Dakota and the Center for Social Research at North Dakota State University.

The Oral Health Program will also be conducting an Older Adult Oral Health Basic Screening Survey in 15 randomly selected long-term care facilities. These efforts will complement each other in identifying need and improving access to care.

NORTH DAKOTA DEPARTMENT OF HEALTH CONTINUES WORK WITH FUNDING FROM DENTAQUEST FOUNDATION



The North Dakota Department of Health, Oral Health Program, (NDDoH) continues its work to address oral health disparities in the United States with funding from the DentaQuest Foundation. The latest phase of the DentaQuest program has been dubbed Oral Health 2020 and will address access to oral health care for the older adult population.

The Oral Health 2020 Initiative aims to eliminate access barriers to oral health care by fostering strong community partnerships committed to collective impact. The North Dakota Department of Health has been working with DentaQuest for several years to develop an oral health action plan that will increase delivery of oral health care to populations that have difficulty finding access to care, either due to financial limitations or geographical limitations.

"We know that many older adult North Dakotans do not have adequate access to oral health care, especially those living in long-term care facilities," said Kimberlie Yineman, Director of North Dakota's Oral Health Program. "By assessing those in need of care, we will be able to make a plan for expansion of our older adult care program in the state."

North Dakota's goals for this phase of Oral Health 2020 include:

- Assessing the impact of earlier phases of the DentaQuest program (titled Oral Health 2014) on North Dakota's older adults
- Working with North Dakota dentists to find out their capacity or interest in providing care to the older adult population in long-term care facilities
- Visiting with 50 North Dakota long-term care facilities to find out about their current interest and need for oral health care for their residents
- Assessing national organizations to find out how they are currently involved in aiding the older adult population
- Expanding the older adult care program in long-term care facilities in North Dakota

In order to accomplish these goals, the NDDoH will work together with local and national partners. Some of the planned changes include:

- Improving the coordination of federal and state Medicaid reimbursement policies to support the delivery of oral health care services to older adults
- Bringing together dental leaders and other stakeholders who work with older adults to create a workgroup that will advocate for improving older adult oral health care
- Promoting the development of social media aimed at older adults focusing on oral health care
- Working with national coalitions to advocate for policy change such as private and public insurance coverage that extends beyond retirement and across the lifespan

"With the help of the DentaQuest grant, North Dakota will be able to help our older adult population receive the quality oral health care they need and deserve," said Yineman. "We are very happy to be continuing with the Oral Health 2020 project."

10th District News: I am happy to inform you that our next District Trustee will be our own, Ken McDougall. He will assume his duties next year at the end of the ADA HOD.

Executive Director's message:

Threat to the ADA; Membership declining. There are too many barriers to membership. We must be inclusive, and we must have innovation. Change will be the new normal. However, even with change, we still must maintain our values. This must be done in order to stay relevant for future generations.

Treasurer's message:

2014: Surplus 1.7 million

2014 Operating reserves: 59%

Concerning trends: How to finance the ADA with the retirement of the baby boomer dentists. Membership revenues are declining.

Unfavorable trends: Falling membership. Half of the young dentists do not renew when they are to start paying full membership dues. Our market share is 64.5%. Due to this trend, dues revenue is declining. Non-dues revenue is also declining except for testing revenue.

Even with these trends, the ADA is financially strong. However, we must recruit more young dentists or otherwise, we'll have to cut ADA programs.

Resolution 77RC: Proposed Amendments to the Sedation and Anesthesia Guidelines. This resolution did pass. If you do sedation, I suggest that you do some research to find out what these entail. Remember these are just guidelines, our state statues still are the legal standards for sedation and anesthesia.

Resolution 96RC: Development of ADA Policy on Dentistry's Role in Sleep Related Breathing Disorders. This resolution passed. The ADA will develop a policy and report back to the 2016 HOD.

Resolution 7: Approval of the 2016 budget. The budget passed with a small deficit.

Resolution 8: Establishment of the Dues. There will be no dues increase. Our dues will be \$522 for active members.
