PRESIDENT'S MESSAGE

Greetings NDDA members!

The ADA Annual Session has just ended, and again, proved to be an amazing display of dentists from around the nation coming together to advocate for you and our patients. If you haven't had the chance to experience the ADA Annual Session, mark your calendars for next October in Honolulu. I can't think of a better place to experience all that the ADA has to offer!

I was honored to work beside our dedicated ADA delegates, Dr. Steve Erlandson and Dr. Paul Tronsgard and also our 10th District Trustee, Dr. Ken McDougall. North Dakota and the 10th district are well represented at the national level and I am thankful for this mentorship and leadership. After hours of thoughtful debate and testimony, the ADA House of Delegates voted upon a number of issues. Among those was a resolution allowing members of the New Dentist Committee who serve as liaisons to special Councils of the Board to now have voting privileges on those councils. This is part of an effort on behalf of the American Dental Association to be more inclusive of and responsive to the needs of our entire membership. The ADA recognizes that it needs to adapt and change and has announced that it will soon launch some exciting new products and services to our members. (I wish I could share more information as it sounds exciting, but all that we were told is that something is coming—so stay tuned!)

I have learned a tremendous amount about organized dentistry and its role in advocating for our profession over the past few years and I look forward to the upcoming year as President. We have been blessed with excellent leadership in Dr. Katie Stewart and those who served before her. Katie's passion for dentistry and her vivacious personality was able to win the hearts of colleagues and legislators, and her dedication to the NDDA was crucial in our defeat of the dental therapist bill last session. I am thankful for her leadership, guidance, and friendship.

At our state meeting, the NDDA House of Delegates passed a resolution to address the opioid epidemic we are facing in our state. As dentists, we need to be one of the voices leading the discussion regarding ways to safely and effectively manage acute pain in our patients. Please familiarize yourselves with the Prescription Drug Monitoring Program and the new rules regarding its use. It is an invaluable resource and is one step you can take in preventing this crisis from worsening.

We are fortunate to be working with such a talented and passionate central office staff. Dr. Brent Holman has been a tireless advocate for dentistry in North Dakota, and through his guidance, we have been able to assemble a stellar team. Assistant Executive Director Tracy Stoppelmoor has been nothing short of amazing! Her day-to-day efforts, along with the planning of the NDDA Annual Session, shows what an asset she has become for our organization in the short time that she has been on staff. If you haven't already heard, Tracy is working remotely but I don't anticipate that you will see any changes in the service that she provides. We have also welcomed William Sherwin to the NDDA as our Government Relations Director. He has an impressive resume and will be an incredible asset. He is eager to meet our members and infuse his energy into our association.

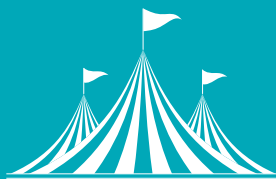

FROM THE EXECUTIVE DIRECTOR'S DESK

While you'd think there would be less activity at the NDDA Central Office as we approach a non-legislative year, that certainly has not been the case! As you know, we have added William Sherwin to our team as Government Relations Director. Will, an attorney, comes with much experience as a lobbyist. He will be a great addition

to our representation in the legislature and in the many oral health meetings with which the NDDA participates. We hope you get a chance to meet Will soon.

As you also know, the NDDA has made addressing the opioid crisis a major priority. Dentistry has a critical role to play in this deadly epidemic and we all bear responsibility to use evidenced-based prescribing guidelines ([NDDA Opioid Prescribing Resolution](#)) and to work to educate our patients about their responsibility. We also are required by the State Board of Dental Examiners to register and use the Prescription Drug Monitoring Program (PDMP) <http://www.smilenorthdakota.org/member-center/industry-updates/pdmp-registration>. **If you have a DEA number, you need to register!** The number of North Dakota dentists that have registered has significantly increased from 142 a year ago to 197 currently. The PDMP is also our best source of data to understand dentists' prescribing habits and whether we are making a difference.

Another issue in which the NDDA has been leading the discussion is the dental assistant shortage in the state. Some numbers from a statewide survey we did in July:

- 70% of dentists have attempted to hire a DA in the last year-40% were unsuccessful.
- 60% plan to hire a dental assistant in the next year.
- 92% think there is a shortage of dental assistants in North Dakota.
- 50% would financially support expanded training options for dental assistants in the state.
- 65% support Expanded Restorative Functions training for dental assistants and 2/3 of those would financially support that training.

We have been working with representatives

from our accredited North Dakota dental assisting program at NDSCS in Wahpeton, other state colleges, and the North Dakota Dental Foundation to seek a sustainable solution. A distance learning expansion of the current program, various financial incentives, and marketing are all being discussed. We will keep you posted!

Finally, the seemingly endless campaign, funded by an out-of-state foundation, to allow licensing of dental therapists in the state, continues. After 4 years of costly lobbying and much distraction from "real" North Dakota solutions to reduce barriers to care, nothing has changed. This model has failed to significantly improve access to care, rates of decay, or cost of care for patients in other states. This model has thus far in rural Minnesota failed in its promise to improve access to care. After 8 years, there are only 9 dental therapists serving a population of 1.2 million rural Minnesotans. Dentists in Minnesota that have worked with dental therapists testified at North Dakota legislative hearings that the business model was not viable and that they found dental therapists in their practices to be unprepared to treat patients. We cannot support a system that not only fails to achieve its objectives but also unfairly places low-income patients in the hands of a less-trained practitioner. The NDDA will continue to do what it has always done: work to improve the dental Medicaid system, maximize our current dental workforce, expand and support non-profit safety-net clinics, and engage with tribal communities. We are making great progress in these initiatives, with much more left to do. Please join us! Please do your part by attending legislative nights in your district and supporting local legislative candidates!

Thanks again to our Trustees and Central Office staff for their dedication to the profession and oral health. A special shoutout goes to our Assistant Executive Director, Tracy Stoppelmoor, who organized an outstanding, successful NDDA Annual Session in Fargo in September. Her dedication and attention to detail is unsurpassed! As always, please contact us if you have questions about any issue!

MY ROLE IN DENTISTRY

I have just finished my first year as your Tenth District Trustee on the American Dental Association Board of Directors. I am thankful for the opportunity and excited for the upcoming year. Our new ADA president, Dr. Joe Crowley, has made his appointments and I will share with you what I will be doing on the board for the next year.

I was appointed to the Governance Committee my first year on the board and will probably serve on it for all four years of my term. This committee reviews the Board Rules and the Standing Rules for Councils, Commissions and Committees. I have been appointed chair of the Board Rules Subcommittee. It may not sound exciting but it requires constant review and updating to ensure the ADA is using best practices in professional association governance.

I have also been appointed as the Vice Chair of the Committee on Annual Meetings. This used to be a council which meant it needed to have the ADA House meet to approve any changes. The Council asked to become a Committee of the Board so it could be more nimble as the board meets more frequently than the House of Delegates. The Committee has been downsized from about twenty-six members to less than fifteen. I nominated Dr. Paul Kirkegaard from Minnesota to serve on this committee and he was elected as one of the nine skill-based members. I was appointed to serve on this committee as I served on the Council on ADA Sessions in the past and will hopefully be able to help the group transition to a Committee of the Board.

I was especially proud to be an FDI delegate in September 2017, and see our own Dr. Kathy Kell from Iowa be installed as the FDI President in Madrid. She will serve in that capacity for two years. The ADA must be at the FDI meetings to ensure that world dental policies do not conflict with the policies of the ADA. I will serve as an FDI delegate again in 2018. You may want to make note that the 2019 FDI convention will be held in conjunction with the ADA Annual Meeting in San Francisco. Remember, all ADA members are members of the FDI.

A new assignment for me will be to serve on the ADA Business Enterprises Inc. board for the next three years. ADABEL is the "for profit" subsidiary of the ADA and is an important avenue for non-dues revenues which help reduce our membership dues. ADABEL has deals with about twenty companies and products that dentists need and by purchasing these products and services through ADABEL it saves you money and earns royalty revenue that is shared with the ADA. Not only does it help the ADA, but it can help every state association too. When a state dental association co-endorses a product, the state receives 40% of the royalties. Forty-nine state dental societies co-endorse the ADABEL program but the average number of endorsed products per state is 11.6 which is about one half of the number of endorsed products. It is estimated that in 2017 ADABEL will contribute over 4.7 million in royalty dollars to the ADA. That is a savings of about \$50 on your ADA dues. It is also interesting to know that ADABEL is forecast to share over \$1.1 millions with states that co-endorse their products. The more we purchase ADABEL products the more we save on our national dues. The more products our state association co-endorses the more we save on state dues. To see what products are available, go to ada.org and click on ADA Business Resources.

I want to remind our members that there is a great need for help with dentists that have been affected by hurricanes, fires and natural disasters. A contribution to the ADA Foundation is a wonderful way to show your support to those less fortunate than yourself. The number of requests for help is at an all-time high and the requests just keep coming in. This is one of the primary purposes of our foundation, to help those in need. Some dental students in Puerto Rico have lost everything and could very easily become depressed at the thought of not being able to finish their education. The ADA Board members took up a special collection to help these students and made a contribution to the foundation to help others in need. I ask you to go to adafoundation.org and make a tax deductible contribution.

NORTH DAKOTA'S DENTAL LOAN REPAYMENT PROGRAM




The North Dakota State Legislature has provided funds to support a loan repayment program for dentists who provide dental services in areas of need in the state.

The application deadline for the loan repayment program is Thursday, March 15, 2018. Loan repayment information and applications are available on the North Dakota Office of Primary Care's website at <http://www.ndhealth.gov/pco/main.asp>.

Once received, reviewed and prioritized by a subcommittee, applications will be forwarded to the North Dakota State Health Council for their decision at its May 8, 2018 meeting.

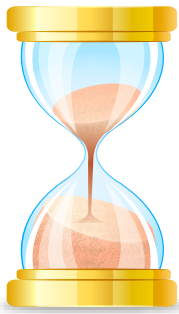

ORAL DIAGNOSIS IN THE PEDIATRIC PATIENT SYNOPSIS:

This course will provide to the attendee the most common radiographic and soft tissue lesions that are common in infants, children and adolescents. 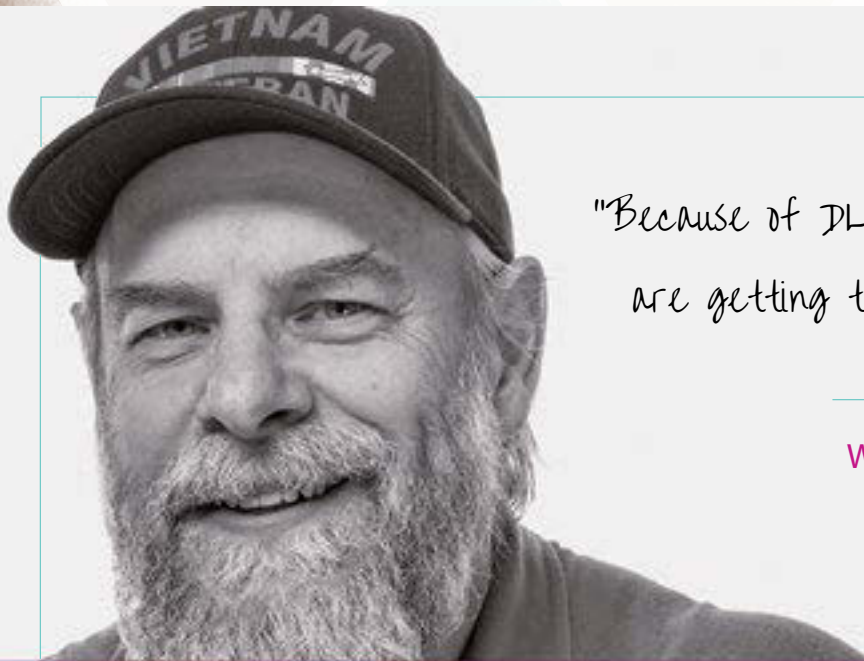

President’s Message:

Accomplishments of the year:

- 1) Council of Scientific Affairs revitalized the trusted ADA Seal of Acceptance program
- 2) Worked more closely with the dental industry
 - a) Oral Health Month with Colgate
 - b) Collaboration with the University of Texas to prevent Oral Cancer
- 3) Strengthen relationships with tribal leaders using the community dental health coordinator.
- 4) Launched ADA credentialing service.
- 5) Launched “Find a Dentist” social media campaign
- 6) Forged ahead to help make licensure portability and elimination of patient based exams.

Treasurer’s Message: As of June we are on track with 2017 budget. Reserves are at 56% of 2017 budgeted expenses. The target floor is 50%. The total reserves including the restricted royalty reserves is 63%. The royalty reserves come from dividends from the Great West insurance programs.

2018 recommended budget is \$130.6 million, with a net surplus of \$134,000.

There is a continued erosion of active full dues membership.

Frog Design, a global design firm, is working with the ADA on a major initiative to increase non-dues revenue. Due to the competitive nature of this initiative, nothing has been divulged on this project.

Priority Item Resolutions:

Resolutions:

#52: Authority to Approve the Budget

House action: did not pass

This resolution would have given the board of trustees the authority to approve the budget. Due to the failure of this resolution, the HOD will continue to have the authority to approve the budget.

#22: The 2018 budget was approved.

#32 RC: Special Assessment.

House Action: Was passed in lieu of Resolutions 32, 32 S-1, and 32 S-2.

The original resolution would have had a special assessment of \$30 for the next two years to help pay for the “Find a Dentist” social media campaign. The price tag is \$6 million a year for 3 years. The remaining cost of the initiative would have come out of reserves. The first year was paid out of the reserves. After debate at the reference committee and at the HOD, resolution #32RC was passed to have year two of the initiative paid for out of reserves and to re-evaluate year three funding in 2018. There will be no special assessment at this time.

#30 RC: Proposed National Commission on Recognition of Dental Specialties and Certifying Boards

House Action: Passed in lieu of #30.

This created a commission that will assist state boards in addressing challenges related to dental specialty issues.

Non consent resolutions:

#23: Establishment of Dues

The dues will remain at \$532.

#47 S-1: New Dentist Committee Liaison Voting Privileges on Councils:

This created that councils will contain a member that is a New Dentist and this council member will have voting privileges.

#17 Development of ADA Policy on Dentistry’s role in Sleep Related Breathing Disorders

This resolution is ADA policy on our role in sleep disorders. It is important to have a proper diagnosis by a physician.
